SHELBY COUNTY WHEEL TAX REIMBURSEMENT PROGRAM INFORMATION

On August 27, 2001, the Shelby County Commission increased the wheel tax to \$50.00 for personal automobiles of county residents. The Commission also added two new regulations to the Shelby County Wheel Tax Reimbursement Program. One of those rules increased **the maximum yearly income to qualify to \$25,000**. The other provision allows persons with current disability license plates to qualify regardless of age, if they meet all the other requirements.

Rules and regulations of the program:

1. Maximum household income per year to qualify is **\$25,000**.
2. Applicant must be **65 or older** at the time of registration renewal, or
3. Persons with a **current disability license plate** may qualify regardless of age. Hangtags ARE NOT sufficient.
4. The vehicle must be in the name of the person requesting a reimbursement
5. Only **one vehicle per household per year** will be eligible for the reimbursement.
6. **Only private licensed vehicle** will be considered for reimbursement.

Application process:

Applications are processed by the Shelby County Trustee and are online at www.shelbycountystate.com. There is no need to apply in person. The application can be completed and mailed with the proper verification attached. If approved, a check will be mailed to the individual on the application, within 8 weeks.

Verification Requirements:

1. For proof of income, copies of Social Security Benefits statements, proof of pension, S. S. I., and any other income should be attached. Copies of checks can be submitted.
2. To show proof of age, a copy of the current drivers license, State ID or birth certificate should be attached.
3. Show proof of payment of wheel tax by attaching a copy of the paid Tennessee Certificate of Vehicle Registration for the current year.
