Our Bank on Memphis Coalition volunteers will be manning tables to talk about bank account, careers in banking and answer questions about credit. Investment Advisors will be available to talk about investing. VITA volunteers will be manning a table to answer income tax questions. Financial Counselors from the Greater Memphis Financial Empowerment Center will be prepared to talk about budgets and how to pay for college.

Linc211 will be available to provide connections to resources throughout our community. The Shelby County Election Commission will conduct a Voter's Registration Drive and have a voting machine for students to test out. MATA will have transportation information available.
